<p>How do I open and manage my account?</p>	<p>This account is available to open and manage online or in branch.</p> <p>You must be a permanent UK resident and aged 18 or over. You can pay into your account by electronic payment, cash or cheque.</p> <p>You must fund the account within ten days of opening. You can fund the account multiple times during this period.</p> <p>The minimum balance is £1 and the maximum balance is £5,000 per person.</p> <p>Customers may hold more than one PlanetSaver - 30 Day Notice Account, but the maximum holding across all accounts with the Society is £500,000 per person (£1m joint).</p>				
<p>Can I withdraw money?</p>	<p>Withdrawals, transfers or closure can be completed online, in branch or by post and are subject to 30 days' written notice, even with a penalty early withdrawals are not allowed.</p>				
<p>Additional information</p>	<p>This product may be withdrawn from sale at any time without notice.</p> <p>We reserve the right to close your account and return the funds to you. We may prohibit further deposits into this product at any time.</p> <p>When we do this, we will update the relevant section within the 'Current interest rates for withdrawn products' page of mhbs.co.uk. We will not personally notify you when we do this. Definitions:

Summary of Changes to General Savings Terms and Conditions (effective 4 April 2026)

Two clauses are being updated:

Clause 11.3.3(b)(ii) The period to close or withdraw from your account without giving notice will reduce from 60 days to 30 days.

Clause 12.4(b)(i)(b) The same change applies here: the notice-free withdrawal/closure period will reduce from 60 days to 30 days.

All other wording in the affected clauses remains unchanged.
