

# 60 Day Notice Account

- 60 days' notice for withdrawals, even with a penalty early withdrawals are not allowed
- Save £5,000 - £500,000
- Variable rate (new rate of 2.40% effective 15 Feb 2025)
- Annual interest paid on 31 October



This account is suitable for someone using their personal savings who can give 60 days' notice to access their funds.

How do I open and manage my account?	<p>This account is available to open and manage online or in branch.</p> <p>You must be a permanent UK resident and aged 18 or over. You can pay into your account by electronic payment, cash or cheque.</p> <p>You must fund the account within ten days of opening. You can fund the account multiple times during this period.</p> <p>The minimum balance is £5,000 and the maximum balance is £500,000 per person (£1m joint).</p> <p>Customers may hold more than one 60 Day Notice Account, but the maximum holding across all accounts with the Society is £500,000 per person.</p>				
Can I withdraw money?	<p>Withdrawals, transfers or closure can be completed online, in branch or by post and are subject to 60 days' written notice, even with a penalty early withdrawals are not allowed.</p>				
Additional information	<p>This product may be withdrawn from sale at any time without notice. We reserve the right to close your account and return the funds to you.</p> <p>We may prohibit further deposits into this product at any time.</p> <p>When we do this, we will update the relevant section within the 'Current interest rates for withdrawn products' page of mhbs.co.uk. We will not personally notify you when we do this.</p> <p>For full terms and conditions for savings accounts, please refer to our General Savings Account Terms and Conditions.
