You can fund the account multiple times during this period.</p> <p>The minimum balance is £5,000 and the maximum balance is £500,000 per person (£1m joint).</p> <p>Customers may hold more than one 90 Day Notice Account, but the maximum holding across all accounts with the Society is £500,000 per person.</p>				
Can I withdraw money?	<p>Withdrawals, transfers or closure can be completed online, in branch or by post and are subject to 90 days' written notice, even with a penalty early withdrawals are not allowed.</p>
