Section 8: Information about tax residency

If you are a US citizen or hold a US passport or green card, you will also be considered tax resident in the US even if you live outside the US. If you have any questions on how to complete this form we recommend that you speak to your tax or legal adviser.

Section 9: How we use the information you provide on this application form

The information we collect about you and your organisation is used for different reasons. This includes managing your accounts, providing our products and services to you, and meeting our legal and regulatory obligations.

In accordance with the General Data Protection Regulation we are required to check your identity and any connected individuals (e.g Directors, Shareholders, Trustees, and Beneficiaries) before you open an account with the Society. We use an electronic verification system to do this. In certain cases we will need further proof of your, or any connected individual's, identity before we can open the account, please refer to our leaflet 'Proving Your Identity' for further details. All documents you provide will be recorded and copied for audit purposes as part of our anti money laundering requirements.

You will need to ensure that anyone affected by any of these requirements is made aware of and agrees to this.
