1. Summary of our assessment

We have assessed that:

- Our Ex-pat Residential product range continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e. the total benefits are proportionate to total costs).

2. Product characteristics & benefits

The products are designed to meet the needs of the target group. The product features and criteria are designed to support these needs.

3. Target market assessment and distribution strategy

The Product is not designed for customers who:

- Have a short-term borrowing need (less than 5 years)
- Require a loan of less than £200k or more than £3m
- Do not have a credible repayment strategy for interest only borrowing
- Are credit impaired borrowers
- Intend to own the property purely for investment purposes
- Are primarily resident in the UK

4. Customers with characteristics of vulnerability

The Product is designed for those with a long term borrowing need, which may include some customers with characteristics of vulnerability or who will experience vulnerability over time.

Residential mortgages should be considered carefully with the advice of a mortgage adviser and other lending options should be considered alongside where appropriate. As this will be the residence of the customer, particular care should be taken to ensure affordability of the mortgage.

Borrowing in a currency other than that from which income is derived adds additional considerations. Potential currency fluctuations should be factored in when determining suitability and affordability.

We have designed our products and their associated lifecycle to take into account the needs, characteristics, and objectives of customers with characteristics of vulnerability. We will work closely with introducers to ensure their needs are met.

We have also tested the Product to assess whether it will meet the identified needs, characteristics, and objectives of the target market, including customers in the target market who have characteristics of vulnerability.

We have in place a framework to achieve good outcomes for vulnerable customers, which includes:

- Education and training for our staff to ensure they have the appropriate skills and experience to recognise and respond to the needs of vulnerable customers.
- A call between underwriter and borrower at underwriting stage to fully understand the customers' circumstances
- A full-lifecycle customer service proposition to ensure the customer position is understood at outset, with flexible options for changing circumstances
- A bespoke approach that allows us to adapt our offering to our customers' needs
- Society-wide monitoring to ensure we continue to meet and respond to the needs of customers with characteristics of vulnerability

Intermediaries should continue to comply with your obligations to ensure that you treat customers in vulnerable circumstances fairly.
