The account can be managed online or in branch.</p> <p>You must be a permanent UK resident and aged 18 or over.</p> <p>You can pay into your account by electronic payment, cash or cheque. You must fund the account within 10 days. The minimum balance is £30,000 and the maximum balance is £500,000 per person (£1m joint).</p> <p>Customers may hold more than one 160 Day Notice Account, but the maximum holding across all accounts with the Society is £500,000 per person.</p>				
Can I withdraw money?	<p>Withdrawals, transfers or closure can be completed online, in branch or by post and are subject to 160 days' written notice, even with a penalty early withdrawals are not allowed.</p>				
Additional information	<p>We reserve the right to close your account and return the funds to you. We may prohibit further deposits into this product at any time.
