What would the estimated balance be after 12 months based on a £5,000 deposit?	<p>£5,125.00</p> <p>This projection is for illustrative purposes only.</p> <p>If £5,000 was deposited on 1 November, the account balance would be £5,125.00 on 31 October the following year. This assumes no further deposits or withdrawals are made, no changes are made to the interest rate and interest earned is added to the account.</p>	
How do I open and manage my account?	<p>This account is available to open and manage online or in branch.</p> <p>You must be a permanent UK resident and aged 18 or over. You can pay into your account by electronic payment, cash or cheque.</p> <p>You must fund the account within ten days of opening. You can fund the account multiple times during this period.</p> <p>The minimum balance is £5,000 and the maximum balance is £500,000 per person (£1m joint).</p> <p>Customers may hold more than one 75 Day Notice Account - Issue 2, but the maximum holding across all accounts with the Society is £500,000 per person.</p>	
Can I withdraw money?	<p>Withdrawals, transfers or closure can be completed online, in branch or by post and are subject to 75 days' written notice, even with a penalty early withdrawals are not allowed.</p>	
Additional information	<p>This product may be withdrawn from sale at any time without notice.</p> <p>We reserve the right to close your account and return the funds to you.</p> <p>We may prohibit further deposits into this product at any time.</p> <p>When we do this, we will update the relevant section within the 'Current interest rates for withdrawn products' page of mhbs.co.uk.
